ETHICS BOARD QUALIFICATION REQUIREMENTS

All members of the Ethics Board shall be at least 18 years of age, be residents of the City, and during their terms on the Ethics Board, no member may hold any other elective office in or be employed by the City of Lake Mills.

Each member of the Ethics Board shall have experience with the types of situations presented when applying an ethics code to specific facts. To satisfy the need for specialized experience, each applicant for consideration for appointment to the Ethics Board shall meet one or more of the following qualifications:

- a. Currently serving, or have in the past served, in an elective or appointive office in a governmental entity; or
- b. Currently are or have been employed by a governmental entity and have been subject to similar ethics codes in such employment; or
- c. Currently are licensed to practice law in the State of Wisconsin; or
- d. Possesses qualifications and experience similar to those listed in this paragraph.
